Natural Resources, & Parks: Public Hearing, Monday, 1/30; Executive Session Thursday 2/2 SB 5094: Adding a Climate Resiliency Element to Water System Plans

- Requires large water systems to plan for a range of climate change related impacts to drinking water supplies including loss of snow pack, drought, sea level rise, flooding, and failure of groundwater to recharge.
- This process will enable the state to become more resilient and will help identify capital projects necessary to protect our water supplies.

#### SB 5112: Updating processes related to voter registration.

 Making these changes will improve access to voting, maintain public confidence in registering only eligible voters, and save time and money through automatic registration instead of through paper forms.

## SB 5154 (The WRAP Act): Improving Washington's solid waste management outcomes

- One of the 4 environmental community priorities for 2023, this bill modernizes Washington's recycling system, including incorporating a beverage redemption system and post-consumer recycled content mandates.
- Reduces excess packaging, increases recycling, refill and reuse, creates a uniform recycling list, and reduces costs for local governments and ratepayers.

### SB 5247: Developing opportunities for service and workforce programs to support climate-ready communities.

- Establishes Washington climate corps network to support climate-related service opportunities for young adults and veterans.
- Establishes a clean energy technology workforce advisory committee to support the expansion of clean energy economy.

SB 5322: Requiring environmental and labor reporting for public building construction and renovation material.

- Creates a reporting system for the carbon footprint of building materials, worker information, and other datapoints like health certifications.
- Senate Committee on Environment & Energy: Public Hearing, Tuesday, 1/31 - The information and database created under the bill will help the state leverage its purchasing power to procure climate smart building materials that support workers.



### SB 5366: Preventing utility shutoffs for nonpayment during extreme heat.

- Climate change is responsible for more frequent extreme heat events, posing a major risk to public health and safety.
  - This bill ensures that people have access to energy to run fans, air conditioners, and refrigeration to protect their health during extreme heat.

### SB 5371: Protecting southern resident orcas from vessels.

• Establishes a 1,000-yard buffer around Southern Resident Killer Whales for all boaters, except for tribal commercial fishing and active commercial fishing vessels, as recommended by WDFW.

### SB 5390: Authorizing DNR to enter into a Spotted Owl Safe Harbor Agreement with the U.S. Fish and Wildlife Service

- Allows completion of a Voluntary Safe Harbor Agreement for private landowners to grow and maintain spotted owl habitat without concern for regulatory restrictions.
- Incentivize an increase in older forests in key areas for spotted owls and other species while allowing landowners to meet their economic goals.



Senate Committee on Early Learning & K-12 Education: Public Hearing, Wednesday, 2/1 SB 5431: Requiring and funding the purchase of zero emission school buses.

- Creates a zero-emission school bus grant program to support the transition to clean buses and protect children's health
- Requires that new school bus purchases starting in 2035 must be zeroemission

### SB 5464: Promoting the fair servicing and repair of digital electronic equipment

- Would require digital electronic product manufacturers to make repair information, parts and tools available to independent repair businesses and owners.
- Extending the life of computers, tablets and cellphones will decrease the need for more resources, energy and transportation to manufacture new products therefore also decreasing greenhouse gas and lowering the costs for consumers.
