#### **HB 1185: Reducing environmental impacts associated with lighting products.**

- Phases out the sales of mercury-containing light bulbs in WA and extends existing producer stewardship program and shifts financial responsibility to manufacturers.
- Would reduce exposure to fluorescent bulbs and tubes that contain mercury (a potent neurotoxin) and ensure safe recycling of bulbs

#### **HB 1368, 100% Clean School Buses: Requiring and funding the purchase of zero emission school buses.**

- [One of the 3 environmental community priorities for 2024](#)
- Sets the state on a transition to 100% clean school buses through new bus purchase requirements.
- Research shows that switching to zero emission school buses improves kids' health and performance in school.

### **HB 2070, CURB ACT: Integrating environmental justice considerations into certain project decisions.**

- Existing laws lack provisions to consider the historical context of environmental racism, overlooking the cumulative health risks and burdens faced by communities.
- The bill incorporates consideration of health-affecting pollutants currently overlooked by existing law.

### **HB 2049, The Re-WRAP Act: Improving Washington's solid waste management outcomes**

- [One of the 3 environmental community priorities for 2024](#)
- Modernizes Washington's recycling system, including post-consumer recycled content mandates.
- Reduces excess packaging, increases recycling, refill and reuse, creates a uniform recycling list, and reduces costs for local governments and makes recycling free for residents across the state.

### **HB 2051: Reducing emissions from small off-road engines.**

- Incentivizes zero emission outdoor power equipment and adopts emission standards for new equipment starting in 2027.
- Fossil-fueled outdoor power equipment causes significant pollution: using a gas-powered leaf blower for one hour creates as much smog-forming and health-harming pollution as driving a Toyota Camry 1,100 miles.

### **HB 2301: Improving the outcomes associated with waste material management systems, including products affecting organic material management systems**

- Addresses composting and other management of organic (yard and food waste) in order to divert the material from the landfill and avoid methane gas generation.
- Reduces food waste and feeds hungry people by providing technical assistance, a grant program, and task force.

### **HB 2401: Providing for the responsible management of refrigerant gases with a higher global warming potential than carbon dioxide that are used in appliances or other infrastructure.**

- Provides a bounty payment for recovering fluorinated refrigerant gases, which are 2000-4000 times more potent than CO2 at warming the planet. About 80% of HFCs in the US are illegally vented at the end of life.
- This bill provides the missing link to incentivize HFC recovery as the EPA phases out new chemical production and requires the HVAC and refrigerant industry to use reclaimed gas.

**HB 2456: Ensuring Connectivity for Washington's Wildlife Through Safe Passages**

- Directs WSDOT and WDFW to implement an action plan for building wildlife crossing structures over and under highways to reduce wildlife-vehicle collisions and protecting key habitat corridors throughout the state.
- Creates two accounts to fund the work.
